Terms and Conditions:

1. **Rental Period:** The rental period begins on the Start Date mentioned above and ends on the End Date. The Lessee agrees to return the Equipment to the Lessor in the same condition it was received, except for normal wear and tear. (Due to the potential of events being back-to-back, AO may request/facilitate a trailer return location)

2. Payment: Upon signing this Agreement, the Lessee agrees to pay the total rental fee (up front for whitetail targets and within 7 days of completion of the shoot for 3D targets – to note: this can be done via cheque as we know some clubs may not have unlimited cash flow up front). The damage deposit will be held until the Equipment is returned and inspected. Any additional charges for extended rental of \$300 per day for late return, or damage will be deducted from the deposit, and the remainder will be refunded to the Lessee at the discretion

of the AO.

3. Use of Equipment: The Lessee will use the Equipment only for its intended purpose and will not make any alterations or modifications to it. The Lessee agrees to load, unload, transport (within an enclosed trailer, to the greatest extent possible) and store all Equipment while in the possession of the Lessee with the utmost care, to avoid damage to the Equipment. The Lessee is required to lock the trailer doors and use the trailer hitch lock to prevent theft.

Targets/stands are to be used for the sole purpose of the registered event.

- 4. **Maintenance and Repairs:** Any damages resulting from undue care in transporting, loading, unloading, misuse or negligence will be the responsibility of the Lessee and may be deducted from the damage deposit. Return of damage deposit may be delayed until such time that damages can be assessed and repairs completed.
- 5. **Damage Deposit:** The damage deposit mentioned for each rental option (required for non-AO sanctioned events) will be refunded by the same means to the Lessee within (14) fourteen days after the Equipment is returned, minus any applicable deductions for damages or additional late return fees.
- 6. **Cancellation:** Cancellation of the rental agreement can be made in writing five (5) days prior to the start of the rental period. Failure to do so will result in a fee of \$100.00.
- 7. **Insurance:** The Lessor is responsible for obtaining and maintaining appropriate insurance coverage for the Equipment during the rental period. The Lessee will be responsible for paying the deductible should a claim be required, as determined by the Lessor.
